

Fairs, Parades and other RCW functions.

Also, the APRCWA Board has received the Incident Reporting Procedures and Incident Reporting Form from Jubilee Insurance. Symposium - Submitted by Jean Bota -Red Deer Lacombe Rural Crime Watch

The APRCWA Symposium and AGM was held on the 16th and 17th of February with the Red Deer/Lacombe RCW hosting the event. It was held at the Lacombe Memorial Centre with 170 RCW members in attendance and participating.

RCW members throughout the province, gathered on the Friday night for a "meet and greet" with a Beef and Pork on a bun supper served. Saturday morning began with a breakfast, followed by greetings from elected officials, President Ken Wigmore - Rd/Lacombe RCW and RCMP members both "K" division and the local Blackfalds Detachment. Many local municipal councillors, Reeves and Mayors were in attendance, as well as MP Earl Dreeshen and MLA Ron Orr.

Our Theme was "Safe at Home in Rural Alberta" with Guest Speakers being Scott McKean and Holly Hollborg. Scott is the Manager, Community Safety and Well-being for the City of Toronto. Holly is a WrapED Project Manager with the REACH EDMONTON Council. Both are members of the Canadian Municipal Network for Crime Prevention (CMNCP) a national group throughout the country. Scott and Holly's presentation was of a rural context; however to begin they both explained their roles within their respective Organization and Associations.

Holly was raised on a farm in the Bingley district, north east of Rocky Mtn House explaining to the group, the difference she has seen over the years at her parent's farm in relation to crime prevention and **Holly Hollborg** safety. Scott was from Toronto and as well as working for the City of Toronto he is part of the Canadian Municipal Network of Crime Prevention (CMNCP) which is a community of practice created to build and sustain capacity of municipalities in:


Prevent and reduce crime and tackle successfully the "hot" issues

Foster community safety and well – being

Increase multi sectoral and collaborative crime prevention strategies that invest compassionately in the futures of young Canadians for the good of all Canadians;

Increase investment in effective, evidence based and cost effective crime prevention strategies in municipalities.

Scott talked about the importance of understanding and knowing how to evaluate issues within communities; beginning with a safety diagnosis, next develop an action plan which needs implementation (mobilization of community) and then evaluation of

He gave an example of Mornelle Court in the suburb of Scarborough; their safety/crime issues and how it paralleled many of the rural/small urban centre issues. He used this analogy and examples of how they handled their fears and concerns to make it a much safer community. He talked about intervention being at all levels as crime is a manifestation of the social issues (mental illness, addiction homelessness, poverty, changing family values, etc...) As Scott noted first we implement the simple things to interrupt /prevent crime (lock windows/doors) have gates, secure valuables and report suspicious activity. Ensure there is communication within communities, be a good neighbour, know how to contact your neighbours, collect newspapers, etc.

It is also connecting residents and community leaders, involving the young people. Ensuring your information and ideas are shared within communities and neighbourhoods. Out of issues come opportunities for communities, to come together and find creative solutions with in Communities. (He told a story about the mothers in Mornelle Court who were afraid to send their children by themselves to school, so a small number of mothers began walking them to school. As time went on, this increased in numbers with the entire community including law enforcement becoming involved)

How do our systems (schools/health/social services/other agencies) support communities, and how do we work together. Everyone is demanding more police, but community safety and wellbeing is all about the social determinants of health, how poverty, addictions, and mental health MANIFEST into crime when individuals don't have access to these services or limited access. Politicians and leadership must ensure the systems are coordinated, ensuring dollars are invested into prevention, really championing prevention at a local level and be proactive with prevention. At a municipal level, there has to be a recognition, development and leadership ensuring community safety and crime prevention with all departments (in the municipality) being on board. Provide a safe community initiative.

At a Rural Crime Watch level our role is ensuring communities are connected and ideas and information is being shared. We are leaders in crime prevention by building relationships through promotion, community involvement and identifying future needs for communities.

Following the presentation, the room was split into 6 groups with a facilitator and each group answered the five questions posed by Scott and Holly;

What are some of the current safety concerns and where are they happening?

What do you want to achieve?

What are you already doing and what do you need to do moving forward?

What does success look like?

What can you bring to a local safety strategy?

Tremendous energy and excitement throughout the room as everyone gave their replies to the answers and plans for going forward. The notes from the workshop sheets were compiled by Jim Willson of Cochrane Foothills Protective Association (thank you Jim) and since given back to the Rd/Lacombe RCW group.

The notes have been sent to all elected officials including Scott McKean who is distributing them throughout his network (Canadian Municipal Network of Crime Prevention). The plan is to first initiate a safety diagnosis with a clear commitment (formal or informal) to improve safety or reduce crime problems which have been heard and identified throughout the workshop. We will be providing more information to the APRCWA as it occurs.

Editor's Note: A copy of the summary sheets has been placed on the APRCWA Website in the Association Area. There is a lot of great information on these sheets and they have some good discussion points for your next meeting.



Highlights from the Annual General Meeting:

This year there were 36 of the 56 Member Associations in attendance for the AGM which represents approx. 16, 000 Members across the Province. The APRCWA welcomed the newest RCWs—East 13 RCW and Corridor Highway 21.

The APRCWA is on track with the Strategic Plan with the iniatives that have been put in place. The Video is being developed, Wise Owl Presentations are continuing and there are other items that are currently in the works. President Trevor Tychkowsky encouraged all RCWs to engage in a Strategic Planning Session; it is a very useful and valuable exercise.

The Memorandum of Understanding between the RCMP K Division and the APRCWA is signed on February 15, 2018. This is a great accomplishment and a timely renewal of the commitment of both parties to Crime Prevention.

Finances are in good order and the Financial Reviewers commended the APRCWA Treasurer, Verna Hart, for the consistency in reporting and the order in which the Financial Records are being kept. Verna reminded those in attendance the Membership Renewal is due August 1, 2018.

Sgt Martin Girard, "K" Division Program Manager for RCW stated the RCW is important to the RCMP and the APRCWA has the full support of "K" Division. The RCMP Service Awards will continue for 2018—deadline for submission for 2018 is August 1, 2018—please contact APRCWA for more information.

Inspector Richard Lyons, from the Fish and Wildlife Enforcement Branch reported there are 55 Field Offices and currently 130 Field Officers to cover the Province. He spoke to the Report –a Poacher going on-line this year to make it easier for reporting. Insp. Lyons discussed the importance of RCW to the Officers and encouraged everyone to pick up a set of Hunting and Fishing Regulations to understand what is legal and what is not. Please report suspicious or illegal activity; Officers ar more effective responding to calls.

Jeana Schuurman Rural Engagement and Communications Specialist announced the winners of 2018 Farmers Advocate Award. There was a great response with numerous Applications being received. This year, the Award was split between Cochrane Foothills Protective Association and Kitscoty Rural Crime Watch. Each RCW will receive \$500.00.

Carsten Erb, from the Solicitor General echoed the RCMP comments about the targeting of Hot Spots in the Province and encouraged all RCWs to build their relationship with Law Enforcement. Crime Prevention Week is set for May 13—21, 2018.

APRCWA President Trevor Tychkowsky gave his last President's Report as he is stepping aside after the AGM. He highlighted the accomplishments of the APRCWA this year with the signing of the MOU, the RCW Video in Production and the endorsement of the One Call Fan Out system. He thanked the Board for their hard work and dedication and support over the years, and thanks all the Member RCWs for their boots on the ground work and initiatives.

New Business discussed was the Presentation of the RCMP Volunteer Service Awards, and an update the RCW Video is being produced to be used Nationwide.

This discussion of RCW signage was discussed and RCWs have were advised that all RCW signs must come from the APRCWA to ensure consistency in the signs and quality. RCWs are not to use 3rd party signs, only those that are purchased from the APRCWA.

The announcement of the Partnership with the Central Alberta Crime Prevention Centre was welcomed by the Board and those in attendance. The APRCWA is partnering with the CACPC for Administration Support and collaboration on grant funding, resources

and information gathering and distribution. The CACPC has their own Board of Directors of with one of the APRCWA Board will join.



ASSOCIATIONS NEWS

East 13 Rural Crime Watch—Submitted by Blake Moser, President

The East 13 Rural Crime Watch communities knew that the is one of the newest crime watch organizations in the province. Spanning the area from Hardisty to Metiskow, Alberta, this organization's name is derived from its location along the east end of Highway 13.

The group was formed in September of 2017, after a group of concerned community members organized a meeting with a local RCMP Constable to give a voice to law abiding discuss the recent outbreak of crime in the area. Historically, there had been little apparent or serious crime in the area. However, in early 2016, community members began noticing an increase in the number of serious crimes throughout local communities.

In May of 2016, the small building that doubles as the bank and post office in the Village of Amisk was robbed at sary paperwork to become a gunpoint. The one employee who works as both banker and Postmaster was tied to their chair while the building was robbed. Nine months later, in February of 2017, the same building was robbed two more times over the Family Day Long members to share and report weekend.

Throughout the summer of 2017, East Central Alberta was hit hard by vehicle and property theft. Numerous Facebook pages popped up with daily stories of stolen vehicles and ransacked farmyards. Members of the East 13


only way to combat the rural crime epidemic facing the area was to get organized, and get in front of it. After speaking with a local RCMP Constable about recent events, members determined that creating a formal, organized group would benefit the community. This group could promote crime prevention throughout the community, advocate on behalf of the local RCMP, and citizens.

In October, The East 13 Rural Crime Watch officially took shape at their first meeting. A Board consisting of 9 Directors and 5 Executive was formed. Members of this group consist of volunteers who represent a large cross-section of community organizations and the public. After the meeting, members got busy filing the necessociety, creating guidelines for new members, and creating a list of priority projects. At the top of the list was establishing a fan-out system to alert locals of crimes in progress, finding a mobile app that would allow suspicious activity to each other, and the creation of a local crime database.

At subsequent meetings, the East 13 Executive determined that the group should join the Alberta Provincial Rural Crime Watch Association in order to

further reinforce the legitimacy of the organization. Two members, President Blake Moser, and Vice President Orrin Ford attended the Provincial AGM and Symposium in February.

Recently, East 13 has established a fan-out system similar to that of some municipal fire and rescue departments in Alberta. The system delivers messages through text message and email. The group has also been very successful in soliciting donations from businesses and individuals throughout their communities, and has partnered with 4 businesses to distribute member sign-up forms. Regardless of the area's relatively sparse population, the group is happy to have signed-up more than 85 members in the last two months. Momentum is building, and the East 13 Rural Crime Watch is looking forward to curving crime, and making a positive change in their communities.


