ALBERTA GOVERNMENT ANNOUNCES PLANTO COMBAT RURAL CRIME.

November 6, 2019, the Alberta Government announced a plan to combat rural crime. The Honorable Minister of Justice and Solicitor General, Doug Schweitzer, announced a plan to deter crime, reinforce property rights and give victims a stronger voice in the justice system. This is as a result of the many Town Hall Meetings, held throughout the Province, by Minister Schweitzer and local M.L.As and the submissions of the Rural Crime Survey. In a snap shot here is what has been announced:

Strengthening Property Rights for Albertans.

- Eliminating Liability of Law-Abiding property owners protecting against trespassers who are, or who they believe are, in the commission of a criminal act.
- Maximum fines of up to \$10,000.00 for a first trespass violation and \$25, 000.00 for subsequent offences as well as possible prison time of up to 6 months.
- Strengthening protections for Land used for crops, animal rearing, and bee keeping, and new penalties for people who enter agricultural operations without authorization.

Rural Alberta Police Integrated Defence Force (RAPID Force)

 Expanding roles of 400 officers in the Fish and Wildlife Enforcement, Commercial Vehicle Enforcement and Alberta

Sheriffs

- Allowing officers to respond to a wider range of calls and help RCMP and other police emergencies.
- Training is underway to have the first officers available in rural Alberta by fall 2020

Supporting Victims of Rural Crime

- Allowing communities to submit impact statements in court when sentencing offenders describing how the crime has affected the community as a whole.
- New Restitution Recoveries Program to help victims collect outstanding payments on restitution orders by giving government greater control over assets of offenders.
- Reducing red tape for victims who would otherwise have to navigate the legal system to collect court-ordered restitution at their own risk, effort and expense.

This announcement is a positive step forward and thank you to all who took the time to attend the meetings, where possible, and complete the on-line Rural Crime Survey.

The APRCWA will continue to network with our Partners, and keep you updated as we receive news and updates.

Many may not know the Farmers' Advocate Office (FAO) was established in 1973, by Alberta Agriculture, to be a resource for Alberta Farmers and Ranchers. The FAO continues to serve rural Albertans through Consumer Protection, with the administration of the Farm Implement Act and Farm Implement Regulation, Rural Opportunity by assisting landowners managing their land asset, and supporting landowners as it relates to interaction with the energy industry, and Fair process through the development and implementation of a peer oriented appeal process.

On the next page is some common questions that are asked in relation to wellsite access on rural properties.

One may ask what this has to do with Rural Crime Watch. It has a lot to do with RCW. Appropriate Access to land, permissions, and knowing who is accessing your land is a portion of the Prevention side of RCW. Knowing what is normal and routine for the activity of an area helps to discern when something "doesn't look right" and may needs to be reported. Knowing who may need access and why helps to determine if the individual is there for the correct reasons.

Commonly Asked Questions: Can I Deny Access to a Wellsite?

The Farmers' Advocate Office is often asked if landowners may deny access to energy infrastructure located on their property. The short answer is no, a landowner cannot deny access to a wellsite.

Even if the company has failed to make their annual rental payment, a company may access the well, facility or pipeline. Sometimes the company accessing land may not be one that is listed on the land title, the surface lease agreement, or Right of Entry Order. The reason is that the <u>Alberta Energy Regulator (AER)</u> may grant another company permission to lead the abandonment and reclamation of a site to ensure environmental and public safety.

Under section 36 of the <u>Surface Rights Act (SRA)</u>, a landowner may apply to the Surface Rights Board (SRB) for a <u>Recovery of Rentals</u> when an operator fails to make its annual rental payments or offers a unilaterally reduced payment under a private surface agreement or Right of Entry order.

Who else may be entering the site?

The following entities have a legal right to access a well, facility or pipeline:

Orphan Well Association (OWA)

The OWA does not take the place of the former operator, and they do not hold any surface lease or license for the well or infrastructure. The OWA is not responsible for paying arrears for annual rental payments. For more information, visit the OWAs website at www.orphanwell.ca

Working Interest Participant (WIP)

A WIP is a company with a beneficial or legally undivided share in a license to an energy resource. When a primary licensee becomes insolvent, the AER can look to the WIP to "lead" on the closure, abandonment or reclamation of the site. A WIP is not responsible to pay any overdue annual rental payments.

Both the OWA and WIPs will work with the landowners and communicate openly about the process and timelines that will occur. They will be engaging all stakeholders during the abandonment and reclamation process.

Note: If a landowner denies to the OWA, WIP's or AER access to the site, the SRB may stop all future payments as per Section 36 (8) of the *Surface Rights Act*.

THE CRIME WATCH APP

The Crime Watch APP is the latest innovation from the APRCWA to help with reporting crime and suspicious activity Province wide by making it easy to find the respective rural RCMP Detachment Reporting Line phone numbers. Two or three clicks and you can make a phone call.

The Crime Watch APP is downloadable, on android and iPhone, from the APRCWA web site. This is a Web-based program that provides a link to the APRCWA Website to give access to the information in the APP.

To download to your phone, tablet or computer go to www.ruralcrimewatch.ab.ca and click on "Use the APP" This will bring you to the Screen that asks if you want to add the link to your Homepage. Menus are different for Android and iPhone, but the intent is the same. Once you have this link, on your Homepage, be sure to have "location Services" turned on for the Web sites.

Included, at the end of this Newsletter is the Crime Watch APP Poster. We encourage you to print some off and post in your Communities to provide awareness of the free APP that is available to the Public.

Editor Note: Personal story—I had occasion to use the APP on my way home from a Rural Crime Watch Meeting. A deer had been hit by a vehicle and was laying in the middle of the highway, and posed a danger to the motorists on that Highway. I pulled over to the side of the road as activated the APP and it came up with the correct RCMP Detachment, for that area. Two clicks and I was chatting with the RCMP to advise them of the hazard; I know they would have also contacted Fish and Wildlife to assist with this call. So simple and convenient to use.

Zone Meetings



You won't want to miss your opportunity to share time with Tom.






